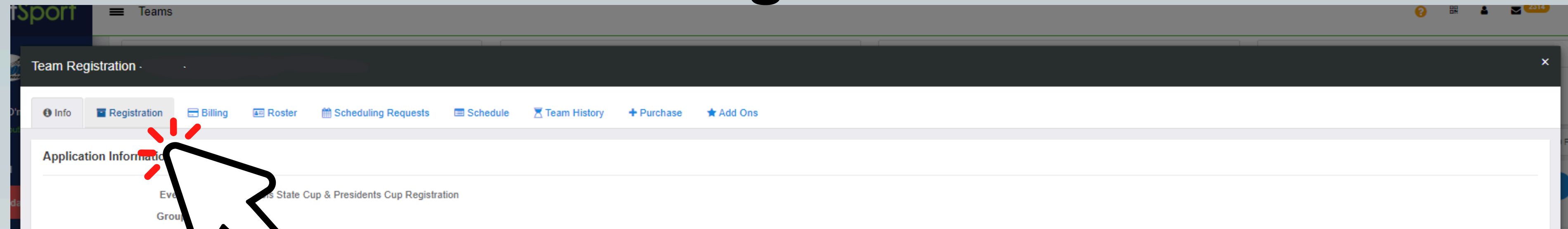

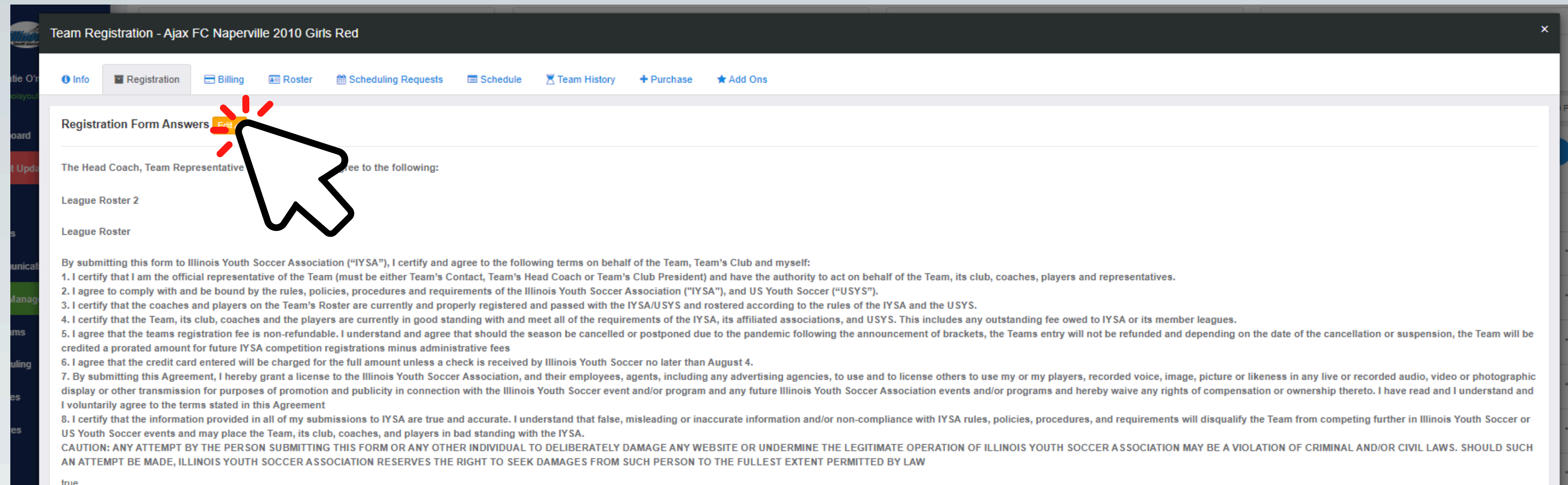

I understand and agree that should the season be cancelled or postponed due to the pandemic following the announcement of brackets, the Team's entry will not be refunded and depending on the date of the cancellation or suspension, the Team will be credited a prorated amount for future IYSA competition registrations minus administrative fees.

6. I agree that the credit card entered will be charged for the full amount unless a check is received by Illinois Youth Soccer no later than August 4.
